



The system eliminates dependency on e-signature platforms, repetitive KYC loops, and jurisdictional validation barriers. Once registered, each identity is minted as an ERC-721 or ERC-1155 token within a sovereign blockchain trust, protected under UNCITRAL, Hague, New York, and Vienna treaty law. This innovation establishes a new global standard for post-jurisdictional legal identity and replaces outdated government-controlled signature verification frameworks with a cryptographically secured, self-sovereign trust instrument.
