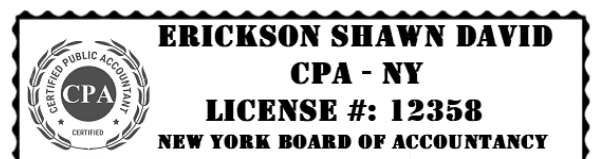

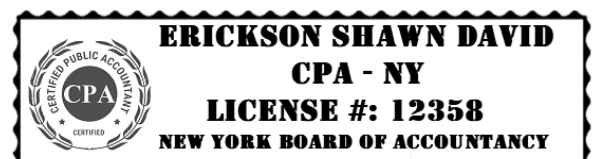

# Independent Auditors' Report

To the Board of Directors and Shareholders of **World Blockchain Bank (WBB)**

## Report on the Digital Banking Assets

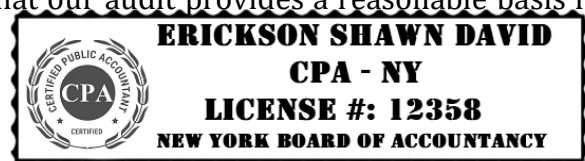
### VALIDATION

We have audited the accompanying digital banking assets of **World Blockchain Bank (WBB)**, which are registered on the blockchain as of **March 1, 2025**. These digital banking assets are the responsibility of the Company's management. Our responsibility is to express an analysis on these digital banking assets based on our audit.

In our analysis, the digital banking assets referred to above **present fairly, in all material respects, the financial position of WBB** as of **March 1, 2025**, and the results of its operations for the period then ended in conformity with **accounting principles generally accepted in the United States of America (GAAP)**.

## Basis of Analysis

We conducted our audit in accordance with auditing standards generally accepted in the United States of America. These standards require that we plan and perform the audit to obtain reasonable assurance about whether the digital banking assets are free from **material misstatement**. An audit includes examining, on a test basis, evidence supporting the amounts and disclosures in the digital banking assets. An audit also includes assessing the **accounting principles used** and significant estimates made by management, as well as evaluating the overall **digital banking asset presentation**. # Management's Responsibility for the Digital Banking Assets

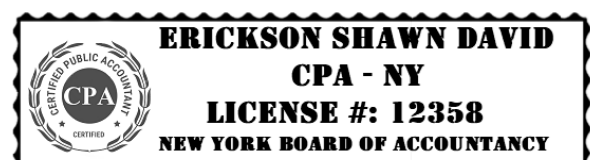
